3	(2) by adding at the end the following new sub-

5	"(b) Notification Requirement.—(1) Not later
6	than 24 hours before calling into Federal service members
7	and units of the National Guard of any State under sub-
8	section (a), the President shall notify Congress of the
9	planned deployment.
