Town of Wellton Police Vehicles	Yuma County	\$324,000	This project will allow the Town of Wellton to purchase four new police vehicles to enhance their aging and unreliable fleet.
Pima County Sheriff's Department Training Facility Upgrades	Pima County	\$1,400,000	This project will upgrade the facilities at the Pima Regional Training Center to improve training opportunities for the sheriff's department and other law enforcement agencies that train at the facility.
Coconino County Public Safety Communications	Coconino County	\$1,980,000	This project will improve public safety in Coconino County by upgrading radio equipment used by first responders and acquiring mobile and portable radios to allow for seamless interagency communication.
La Paz County SWAT Team Response Vehicle	La Paz County	\$579,000	This project will add a response vehicle to support the La Paz County's SWAT team's ability to respond to critical incidents throughout the county.
Nogales Police Vehicles	Santa Cruz County	\$481,000	This project will equip the Nogales Police Department with five new incident command response vehicles. These vehicles will replace existing and outdated response vehicles that are used in part to respond to border security-related incidents.
Safford Police Department Mobile Command Center	Graham County	\$250,000	This project will provide an interagency mobile communications vehicle to improve emergency response in Graham County.
Williams Police Communications Infrastructure Upgrades	Coconino County	\$462,000	This project updates 25-year-old radio infrastructure in the City of William' 911 dispatch center, serviced by both police and fire departments in the region.
Douglas Police Equipment	Cochise County	\$627,000	This project will provide a new armored response vehicle, new imaging technology, and new vehicle computers for the Douglas Police Department.

Sahuarita Police Radios	Pima County	\$810,000	This project will upgrade handheld radios for the Sahuarita Police Department. The department's current technology is more than 10-years old and can no longer be repaired or supported.
Tucson Police Vehicles	Pima County	\$4,200,000	This project will provide new police response vehicles for the Tucson Police Department. The Department's current vehicles are aging and in need of replacement.
ASU Center for Heat Preparedness	Maricopa County	\$2,062,000	This project will establish and provide equipment for the ASU Center for Heat Preparedness to develop solutions that make infrastructure more resilient to extreme heat.
ASU Chip Water Reuse Technology	Maricopa County	\$2,062,000	This project will develop innovative water reuse technologies and infrastructure for advanced microelectronics manufacturing.

University of Arizona Extractive Metallurgy and Recycling Pilot Facility	Maricopa County	\$3,000,000	This project will design and construct a centralized water treatment facility for the City of Tolleson.

City of Safford for Water Line Upgrades	Graham County	\$2,100,000	This project will replace the City of Safford's 1930s-era water transmission mains that provides water to 3,500 residents to increase the reliability and capacity of their water transmission
Town of Eagar for Spring Line Restoration Project	Apache County	\$1,500,000	This project will replace the Town of Eagar's aging and deteriorating water system, ensuring a safe, reliable, and sustainable water supply.
Page Water Treatment Plant Expansion	Coconino County	\$2,550,000	This project will expand capacity of the Page water treatment plant by increasing pumping and disinfection capacity in order to meet peak demands in a drought-stricken region.
Tri City Regional Sanitary District Sewer Upgrades	Gila County	\$2,850,000	This project will bring sanitary sewer service to residents and businesses in Gila County. Currently there is no sanitary sewer services, and the region relies on failing and unsafe septic and cesspools to collect waste.
Colorado River Sewage System Treatment Facility Replacement	La Paz County	\$2,000,000	This project would fund the construction of a new wastewater treatment facility to serve the Town of Parker and the Colorado River Indian Tribes.
City of Tolleson for Wastewater Digester Project	City of Tolleson	\$1,092,000	This project will design and construct a centralized water treatment facility for the City of Tolleson.
City of Mesa for Sewer Pipe Rehabilitation	City of Mesa	\$1,092,000	This project will support the inspection, assessment, and repair of approximately 41 miles of sewer main and 750 manholes in Mesa.
